Search Committee invites applications for the post of Vice – Chancellor

Solapur University, established by the Government of Maharashtra in 2004, is an institution of Higher Learning, offering technical, vocational, professional and liberal education programmes at diploma, graduate and post graduate level using the modern communication technologies under an open system of Higher Education. The university campus is located in a sprawling area of 517 acres near Solapur city with excellent infrastructure and facilities conducive to the pursuit of higher education and research. The university has four major faculties: Science & Technology, Commerce & Management, Humanities and Inter – disciplinary studies, and has 6 Schools with 18 post-graduate courses.

Within a short span, it has made rapid strides in achieving academic excellence in higher education and research of high quality in emerging areas. Best practices towards improvement of curricula and evaluation of student performance are being followed. The university has 109 affiliated colleges (both aided and unaided) within its jurisdiction. The Hon'ble Chancellor of the university (H.E., the Governor of Maharashtra) has constituted three – member Search Committee for recommending suitable names for the post of Vice – Chancellor which has fallen vacant.

The Search Committee now invites applications from eminent academicians endowed with administrative abilities and leadership qualities. The essential qualifications and other requirements for post of Vice – Chancellor are laid down in the Section 11 of the Maharashtra Public Universities Act, 2016 read with Order dated 27.05.2009 issued by Higher Education Department, Government of Maharashtra. The details thereof can be accessed from the website. The tenure of Vice – Chancellor is for a period of five (5) years or till attaining the age of 65 years, whichever is earlier and she/he will not be eligible for re-appointment.

Interested persons fulfilling the requirements may apply giving detailed résumé in the prescribed format clearly bringing out the research, teaching and administrative experience/achievements, along with a two page justification for her/his candidature, two page vision statement for the university and the names & contact

details of three distinguished persons well acquainted with her/his work. Leading universities/Institutions can also suggest eminently suitable persons for consideration of the Committee.
